### **Awards:**

There will be at least **\$5,000** in purchase awards presented at the opening reception.

### **Eligibility:**

This Regional Exhibition is open to all Chicago-area artists, 18 years of age or older. All work must be original and completed in the past 10 years. All work must be hand delivered by the artist or a representative of the artist. Eligible media include: painting, drawing, printmaking, photography and sculpture. Faculty and Staff of The Illinois Institute of Art-Chicago are not eligible.

### Liability:

Artists should insure their hand-delivered or shipped work, as The Illinois Institute of Art-Chicago will not be liable for damage while in transit. All artwork accepted into the exhibition, however, will be insured for the time that it is in the gallery's custody.

### Delivery:

**All accepted work must be hand delivered. Hand delivered** works must arrive at Gallery 180 of The Illinois Institute of Art-Chicago prior to, or on **Friday, October 10**, between 10-12 pm [or by appointment]. Following the close of the exhibition, hand-delivered work must be picked up on **Friday, November 7**, between 10-12 pm [or by appointment].

### Juror Results:

The results of the juror will be mailed by August 18, 2008. The Illinois Institute of Art reserves the right to refuse to exhibit any work it deems unacceptable due to poor craftsmanship or significant departure from submitted representation.

### Image Preparation:

Entries can be submitted in slide format or as files on CD. Work submitted must represent the actual work to be delivered to the gallery. Artists may submit up to three images. Images must be clearly labeled with the artist's name, title of work, media, size, and the year completed. Digital file size should be 4" on the long side with the image having a resolution of 300 dpi. For slide entries, place a red dot in the lower left corner of the front side of the slide. Images submitted on CD should include a corresponding information sheet. Non-accepted work will only be returned if a self addressed stamped envelope is enclosed. Slides and digital files of accepted work will be retained for the archives of Gallery 180 of The Illinois Institute of Art-Chicago.

### Presentation:

All entries must be suitably presented for installation and wired for hanging. Works on paper and photography must be framed with a white or off-white mat.

### Sales:

All submitted works must be for sale. The Illinois Institute of Art will retain a 50% commission from all sales. **Payment from sales will be made to the artist, after the close of the exhibition.** This exhibition will be highly publicized to increase sales. Alternative events, related to the "Real Estate" theme, will be scheduled during the duration of the exhibition.
